Most states require a completed vehicle bill of sale to register a motor vehicle at the DMV, and many recommend using a bill of sale if you are buying or selling any item over \$500. Some states have specific requirements as to what must appear on a bill of sale form for it to be accepted. The document is evidence of an agreement between the two parties that a sale has taken place between them. At this stage, both parties agree on a payment method and any special conditions of the sale, such as a warranty or financing. It is a legally binding document that is commonly used when the former owner transfers possession of the goods to a new owner. The seller's bill of sale form will show the date the vehicle was sold and the buying party's information. If you've bought a vehicle, you'll need to register it at the Department of Motor Vehicles (DMV) and pay sales tax. Warranty Provision — A written guarantee that the seller will repair or replace the item if there are any defects over a specified period of time. Not all states require a bill of sale to be notarized. If you don't include a warranty provision in your bill of sale, the item is sold "as-is."
